Product Care Registration Guide for Ontario Hazardous and Special Product (HSP) Producers

September 2021



Product Care is ready to help Producers meet their requirements under the Hazardous and Special Products (HSP) regulations O.Reg. 449/21. Product Care is a federally incorporated not-for-profit organization, managing Extended Producer Responsibility programs across Canada for 27 years and has and industry led board. We launched first Ontario Industry Stewardship Program (ISP) for paint in 2015 followed by pesticide, solvent and fertilizer in 2016. Currently, Product Care manages 16 programs in 9 provinces plus provides services to 3 client programs, ensuring Producers are compliance with local regulations.

Product Care has registered as a PRO (registration number: 00008937) with Resource Productivity and Recovery Authority (RPRA), and is registered for the following products: solvents, paints and coatings, pesticides, fertilizers, refillable propane containers, non-refillable and refillable pressurized containers.

The information below explains the procedure to "pre-register" with Product Care as PRO for HSP Products. Final registration can be completed after the Producer registers with RPRA for HSP. The date of availability of the RPRA HSP registration portal is not known. Existing Product Care members as well as new members will need to register with Product Care for HSP products using the Product Care member portal. How to Register with Product Care for Ontario HSP products

1. If you are NEW Ontario Product Care member

- **Step 1**. New HSP producers will be required to create an account with Product Care. Click on this link to create a new account
- Step 2. Complete the "Contact information" screen and click the "next" button

You will be taken to the "Steps required to appoint Product Care as your Producer Responsibility Organization (PRO) for Ontario" screen (see instructions below for "existing member"). Read the instruction on this screen and follow **steps 2** and onward for:

• "HSP Pre-Registration" if you have not registered with RPRA,

or

• "HSP <u>Final registration</u>" if you have registered with RPRA and have a RPRA registration number.

2. If you are an existing Ontario Product Care member

Producers can register with Product Care for HSP products through the <u>member reporting portal</u>.

A. <u>HSP Pre-Registration steps</u>

- Step 1. Log into the member reporting portal using your login credentials
- Step 2. review this information screen: "Steps required to appoint Product Care as your Producer Responsibility Organization (PRO) for Ontario"
- Step 3. Pre-registration (if you do not have a RPRA registration number)

a. Click on the "Select the HSP Product" button

b. You may also "view only" the Product Care PRO appointment agreement by clicking on

Step 4. "Edit Programs" Select the HSP product(s) you want Product Care to manage on your behalf, then "next". Note: <u>select only HSP products</u> in this step.

Step 5. "Supplementary Agreement to appoint Product Care as PRO for Ontario programs"

- a. Click on "view here" to view the revised Ontario Supplementary agreement.
- b. Once done, click on the "VIEW ONLY" button, then the "next" button at the bottom of the screen.

B. HSP Final Registration steps (for new and existing members)

Final Registration (this step can only be completed once you have registered with RPRA and have a RPRA registration number)

Step 1. Log into the <u>member reporting portal</u> using your login credentials.

Step 2. At the "Steps required to appoint Product Care as your Producer Responsibility Organization (PRO) for Ontario" information screen, click on the "Continue to Final HSP Registration" button.



Step 3. "Edit Programs" View the HSP Products previously selected and click "next" to continue.

You may add HSP products to your selection at this point if needed. If you need to remove HSP products previously selected, please contact <u>ontario@productcare.org</u>

Step 4. "Supplementary Agreement to appoint Product Care as PRO for Ontario programs"

- a. Enter the RPRA Producer Registration number (this is a required step to complete final registration)
- b. Click on "Yes I agree" to the Ontario Supplementary agreement and click the "next" button.

Your registration request will be reviewed by PCA, usually within 2 business days, and:

• You will receive an initial email with your member number and user name. You can then log in to the system to update your account information, and add contacts to your account.

Upon verification and acceptance of your account by PCA, you will receive a confirmation email for each program you registered for and you can then file EHF reports for that program.

Other Registration options

"Ask me later"

If a member is undecided or not ready to pre-register or appoint Product Care as their PRO, they can click on the "Ask me later" button which will take the user back to the home screen where they can log out or the member portal. Upon logging back into the member portal, the member will be presented with HSP registration options (step 2).



"Decline Registration"

If a member does not want to pre-register or appoint Product Care as their PRO. The member can click on the "Decline Registration" button which will take them back to the member home page. HSP registration options will not appear once a member has declined registration.
