



## Drop-off checklist

- ✓ Products must be in original container, with label intact.
- ✓ Container is tightly sealed.
- ✓ Gasoline must be returned in a 25L or smaller sealed jerry/gas can.
- ✓ Multiple products have NOT been mixed together in one container.

## Hazardous and Special Products (HSP) – Alberta

Starting April 1, 2025, Product Care Recycling will be responsible for the collection and management of HSP in Alberta. Residents are encouraged to bring their unwanted or leftover HSP to their nearest collection site or to a scheduled collection event/round-up.

Some Alberta municipalities may continue to accept HHW products that are NOT included as part of the HSP program. Residents are encouraged to check with their local municipality, review the accepted HSP product list, and locate nearby recycling sites through the recycling locator.

## Accepted Flammables & Gasoline

- Acetone
- BBQ Lighter fluid
- Camping fuel
- Fondue fuel
- Flammable degreasers
- Flammable fuel treatment and additives
- Flammable liquid adhesives
- Flammable lubricants
- Kerosene
- Methanol
- Methyl hydrate
- Non-refillable fuel cylinders



Products must display the flammable hazard symbol.



Gasoline must be returned in a 25L or smaller sealed jerry/gas can.



## Accepted Toxics

- Automotive additives
- Automotive parts cleaners
- Automotive antifreeze
- Tar remover
- Bug remover



Products must display the toxic hazard symbol.



## Accepted Domestic Pesticides

- Weed killer
- Hornet killer
- Rat poison



Products must display Pest Control Product (PCP) number and the word 'domestic' on the label.



Products must display the word 'DANGER' or 'WARNING' on the label together with a black octagon or diamond symbol.



## Accepted Corrosives

- Grout cleaner
- Masonry cleaner
- Rust remover
- Kitchen cleaner
- All-purpose cleaner
- Ammonia



Products must display the corrosive hazard symbol



## Not Accepted Products\*

- Insect repellents intended for personal use
- Sanitizers, disinfectants, and anti-microbial products
- Ammunition
- Batteries
- Biodegradable cleaners
- Caulking compound
- Commercial, industrial or agricultural products
- Diesel
- Cosmetics and beauty products (e.g. perfume, deodorant)
- Drugs, medicines, and other health products
- Medical sharps
- Fertilizer
- Mercury switches
- Oil
- Powder forms (solid) of masonry products, cement, grout, mortar, plaster of Paris
- Refillable propane cylinders
- Wine and distilled spirits

\* While these products are not HSP accepted products, some may still be accepted by your local community operated HHW facility or collection event. Check with your local community to confirm if these non-HSP products can be accepted.



Max. flammables size: 10 litres/kg  
Max. aerosol size: 24oz/680g  
Max. gasoline size: 25 litres
