## Introduction

The Collection Guidelines are intended to provide practical guidance to generators who will be participating as a Large Volume Generators in the Manitoba Paint, Paint Aerosols, and Single use Compressed gas cylinder Recycling Program (the “Program”). These guidelines are not intended to replace any Provincial and Federal regulations standards, acts or regulations nor relieve the operator of any obligations under the regulations. Product Care Association (Product Care) accepts no responsibility and assumes no liability arising from the use of the information contained in this publication.

## Background Information

The Household Hazardous Material and Prescribed Material Stewardship Regulation under the Waste Reduction and Prevention (WRAP) Act, requires brand owners of certain types of paint to operate a province wide paint recycling program to manage post-consumer leftover paint. Product Care is the non-profit industry association which has developed, and will operate, the Program on behalf of the paint brand owners.

## Products accepted

The Program includes architectural paint (household paint) in containers under 25L in size, all paint aerosol, (automotive, industrial etc.) and single use compressed gas cylinder, (i.e. camping cylinders).

There are two major types of architectural (household) paints sold to consumers: latex or water-based paints and alkyd or solvent-based paints and finishes.

Both types are accepted by the program regardless of the sheen/gloss or finish, solid or transparent.

The Program accepts leftover paint from any category of paint consumer including:

- Homeowners
- Commercial painters
- Businesses

## Collection Procedures

### Supplies

The Program will supply the following for paint, paint aerosols or single use compressed gas cylinders to the generator:

1. Collection bins for paint can and pails containers.
2. 205 L (45 gallon) steel drum for paint aerosols.
3. 205 L (45 gallon) steel drum for single use compressed cylinders.



### Packaging and storing Paint, Aerosols, and Single use Cylinder products correctly:

- Place paint 20L pails paint on bottom in the collection bin and 1 – 5L cans on top of pails in the collection bin. If no 20 L pails, stack cans on top of each other.
- All paint containers should be packed upright and tightly together, ensuring handles are down and allow the lid to fit properly.
- Pack paint aerosols into the 205 L drum (do not stand upright)
- Pack single use cylinders in the 205 L drum (do not stand upright)
- Do not overfill bin or drums.
- Replace the lid on the bin securing with weight if it is outside.
- Replace lid on drum.
- Also refer to the Large Volume Generator Application

### Preparation for shipment

- Refer to the Large Volume Generator Application instructions
- Ensure the lid of the collection container is secure.
- Sign the shipping document provided by the transporter.
- If your shipment is being picked up by a third-party transporter, additional shipment instructions will be provided for paperwork.

## Shipment Procedures: Arranging for shipment:

- Refer to the LVG application and pick up request form Documentation:
- Copies of completed shipping documents (provided by the transporter) should be kept for two years.

## Manitoba Large Volume Generator Program

Product Care provides commercial Large Volume Generators a direct pickup program for paint, paint aerosols and non-refillable propane cylinders. It's designed specifically for users who generate large volumes of paint, paint aerosols and non-refillable propane cylinders.

### LVGs will be required to:

- Qualify for the LVG program based on an accumulation of a minimum of 1 pallet worth of material and all containers must be in reasonable condition, not leaking, properly sealed, have original labels with legible identification.
- Example: 1 Tubskid of liquid paint, or 4 drums of aerosols or 4 drums non-refillable propane cylinders) for collection.
- Submit the completed LVG application form to [MBopspaint@productcare.org](mailto:MBopspaint@productcare.org).
  - Provide Product Care with a Manitoba Generator number (MBG) which covers the materials you will be transporting under the LVG program.
  - This registration is required under Section 4(1) of the [Hazardous Waste Regulation \(M.R. 195/2015\)](#)
  - Application can be completed online at link below (See table below for TDG details required on application)

- Pack the program items into collection containers, refer to [www.productcare.org](http://www.productcare.org) for instructions.
- Email: [MBopspaint@productcare.org](mailto:MBopspaint@productcare.org) to schedule shipment.
- Only loads with an MBG#, authorized application and scheduled appointment will be accepted.

### Product Care will provide:

- Collection containers (Tubskids and drums) required for packing safely the accepted materials.
  - Tubskids hold ~432 litres of containers (e.g. 108 x 4 litre cans or ~9 x 20L pails).

- Drums hold ~80 litres of containers (e.g. 80 x 1L cylinders or ~ 100 aerosol cans).
- Tubskids with lid and metal 205L drums are provided by Product Care for your site to pack the materials.
- How to package videos can be found on [Product Care](#) website.
- If lost, damaged, or not returned, a replacement fee of \$500 / tubskid, \$100 / tubskid lid and / \$75 / drum will be charged.
- Information on the material Product Care will accept, is in Appendix A.
- Transport to and from the generator location to deliver the empty containers and pickup full collection containers.
- Disposal / recycling costs of the material collected.

**IMPORANT:** The disposal costs for any items sent in collection containers that are not program paint, paint aerosol, or non-refillable propane cylinders will be billed to you at cost plus 50%.

- If items are sent in with the collection containers that are not program paint, paint aerosol, or non-refillable propane cylinders, Product Care reserves the right to discontinue providing this service to you.

**NOTE:**

This program is intended for *post-consumer* products stewarded under the Product Care program, specifically paint, paint aerosols and non-refillable propane cylinders. Please refer to the list at the end of this document for accepted products within the program and contact Product Care if you are unsure of whether your material qualifies.
