

# ALBERTA ENVIRONMENTAL HANDLING FEES – HAZARDOUS AND SPECIAL PRODUCTS (HSP)

This program is funded by Environmental Handling Fees (EHFs) remitted by Product Care’s industry members. EHFs are paid by Product Care’s members based on their unit sales in the province where Product Care has programs.

EHFs are taxable, as they are considered to be part of the price of regulated products. While the taxes are remitted to the government, no part of the fee itself is remitted to the government.
