

YUKON ENVIRONMENTAL HANDLING FEES – HAZARDOUS AND SPECIAL PRODUCTS

This program is funded by Environmental Handling Fees (EHFs) remitted by Product Care’s industry members. EHFs are paid by Product Care’s members based on their unit sales in the jurisdiction where Product Care has programs.

In the event that the revenue generated from EHFs is insufficient to cover program costs, a financial true-up as defined in the PCA Yukon Supplementary Membership Agreement will be required to ensure the financial sustainability of the program.

EHFs are taxable, as they are considered to be part of the price of regulated products. While the taxes are remitted to the government, no part of the fee itself is remitted to the government.
